Treasurer's Report Jim Hrabosky reviewed the February Operating, Capital, Academic Enhancement and

Restricted Funds Budget Summaries, as well as the Enrollment Reports. The Budget

President's Report Dr. Neupauer reported on the following:

State Activities

-All Pennsylvania college and university presidents are still evaluating the impact of the state budget. There is a 10% hole in our budget which equates to \$840,000. We are trying to quantify line items to be cut or zeroed from the Governor's budget. A cut in Distance Education is of concern. Community Education Councils and New Choices

could be zeroed out.

-Dr. Neupauer attended the American Council on Education conference on March 5-7. Forty percent (7.6 million) of college enrollment in the United States is at community colleges. Federal government aid has increased significantly since 1990. The following

cost increases have occurred since 2000:

Public higher education 45% Private higher education 23% Medical care Community colleges 9% 43% Medicine 37% Median family income -5% 31%

Mr. Schultz reported that the Committee met on March 15 to evaluate the impact of the state budget cut and the loss of federal stimulus funds. Thank-you to Jim Hrabosky for his work on the preliminary budget numbers.

With funding from the Federal Dept. of Justice grant, three classrooms can be upgraded in the Public Safety Training Facility. No College funds will be used for the upgrade. The bid award follows:

Action Item

Resolution 11-01 - Award of Advanced Disaster Management Simulator Audio Visual Support Bid

Mr. Schultz moved to approve the bid of \$130,565 to Dagostino Electronic Services of Pittsburgh, PA for audio support for the Advanced Disaster Management Simulator. Dagostino Electronic Services submitted the only responsible bid for this grant-funded project. The grant budget is \$147,000. Motion Carried.

The PA Commission for Community Colleges requested each college's policy on reserves. Jim Hrabosky submitted ours.

The Finance Committee recommended Jim Hrabosky move \$250,000 from the operating fund to the capital reserve fund - \$130,000 from the Children's Creative Learning Center insurance and \$120,000 for collateral on the Student Success Center.
