Jim Hrabosky thanked Maher Duessel CPAs for the quality of their work. He also thanked Jake Friel and the Student

Services, HR, Con-Ed, Academic Affairs and IT staffs.

Jim Hrabosky reviewed the October Operating, Capital and Restricted Funds Budget Summaries as well as the 2013 vs. 2014 enrollment comparison report.

- The Council of Presidents met in Hershey on October 30-31.
- -The annual Southwest Regional Trustee meeting was held at BC3 on November 20. The Community Colleges of Allegheny, Beaver, Butler and Westmoreland Counties were in attendance.
- -A Middle States conference is scheduled for December 3-5 in Washington, DC. Trustee representatives at the conference are Ms. Geyer and Ms. Staible.

#### **College Activities**

- -Dr. Neupauer spoke at the Corridors of Opportunity event held on October 22, in Cranberry Township. The event was sponsored by the Pittsburgh Business
- -The College is moving forward with a bid on the Unified Economic Development Plan for Butler County.
- -Dr. & Mrs. Neupauer participated in the Spirit of Christmas Parade in downtown Butler on November 29. It was a huge success with about 30,000 attending. BC3 students and staff decorated a horse-drawn wagon for the parade as well.
- -An Open House was held on October 23. A total of 171 applications were submitted.
- -Early spring enrollment numbers show a 3.5 percent decline in credits over this time last year.
- -The Nursing dept. is preparing for a reaccreditation visit in January.
- -Committee work continues on the Middle States reaccreditation process.
